12. I understand that the University may refuse to issue a CoE if a positive financial assessment is not made by the University or its agent.
13. I understand that even if the University or its agents make a positive assessment of my financial situation, that I should only accept this offer if I have sought appropriate financial advice and am satisfied that I have sufficient funding to complete my education.
